Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to VR-HERE via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and /or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;
GDPR	the UK General Data Protection Regulation;

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of VR-HERE and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, VR-HERE is the "data controller". This means that VR-HERE determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:

How we collect Data

Data that is given to us by you

Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:

This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Our use of Data

- 11. We may use your Data to show you VR-HERE adverts and other content on other websites. If you do not want us to use your data to show you VR-HERE adverts and other content on other websites, please turn off the relevant cookies (please refer to the section headed "Cookies" below).

Who we share Data with

- 12. We may share your Data with the following groups of people for the following reasons:
 - a. our employees, agents and/or professional advisors To allow us to contact customers in case of changes to their bookings :
 - b. third party service providers who provide services to us which require the processing of personal data To facilitate booking and payment process;
 - c. third party payment providers who process payments made over the Website To facilitate booking and payment process;

in each case, in accordance with this privacy policy.

Keeping Data secure

- 13. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.
- 14. We are certified to PCI DSS. This family of standards helps us manage your Data and keep it secure.

Data retention

Your rights

- 19. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Cookies
